We OPPOSE HB 939 - If passed, this bill would prohibit a person from carrying a firearm within 100 feet of a voting location, including a ballot drop box. In addition to the problem of restricting the right to bear arms, this bill could create a situation where someone accidentally violates the law simply by walking on the sidewalk near

a drop box. The original text of this bill would have also prohibited a firearm in a vehicle that was within 100 feet
